





Congratulations on the purchase of your Kinetico Water System.

Kinetico Incorporated warrants its Water Softeners, Filters and Membrane Systems to be free from defects in material and workmanship according to the following terms and conditions:

What is Covered?

Any faulty parts will be replaced at no extra charge for the part, if it fails within the following time periods originating from the date of purchase of your system:

I. Softeners*

- 4 Four years on Compact Commercial Softeners, Commercial Plus Softeners and Kinetico Softeners (ambient temperature models)
- 4 Four years on Kinetico Residential Water Softeners
- **7** Three years on Powerline™ Softeners
- **1** One year on Compact Commercial Softeners (high temperature models)

(*When oxidizing agents are present, the softener must be a Kinetico Carbon Combination System or be preceded by a Kinetico Dechlorination or CRS System. Additionally, the carbon, Chloraban™ or Sulfaban™ media in these systems must be maintained and replaced according to the system's operating instructions. If these conditions are not met, the ion exchange resin is not covered by this Limited Warranty.)

II. Filters

- 4 Four years on Commercial Plus Filters and Kinetico
- 4 Four years on Kinetico Residential Water Conditioning Systems, Aerators, Neutralizers, Upflow Dechlorinators, Chloramine Reducing Systems (CRS) and Arsenic Guard® Systems
- **3** Three years on Powerline Filters

III. Membrane Systems

- 1 One year on all NSC-Series, H-Series, S-Series, ROAX N-Series, TQ Series, TL Series and TS Series commercial reverse osmosis systems.
- 1 One year on Kinetico K5 Drinking Water Station® and AquaKinetic® A200

IV. Other Warranted Products

Other Kinetico products, components and accessories that are not specifically mentioned elsewhere in this Limited Warranty [including but not limited to storage tanks, valves, pumps, filter housings and electrical controls] and/or not manufactured but distributed by Kinetico through authorized dealers, are covered for a period of **one (1)** year from date of purchase. All replacement parts are covered for a period of **one (1)** year from the date of purchase.

V. Replacement Parts

Any replacement parts for Products specifically identified in this Limited Warranty shall be warranted for the remainder of the Products' original warranty period, only. All new replacement parts not mentioned elsewhere in this Limited Warranty are covered for a period of **one (1)** year from the date of purchase.

This Limited Warranty does not include freight or labor charges.

Extension of Limited Warranty to a Subsequent Installation

The ORIGINAL OWNER may move the system to another location. The influent water quality at the subsequent location MUST, however, be within your system's operating specifications. Please contact a local authorized Kinetico dealer prior to installation at another location.

Limits on this Warranty

This Limited Warranty for Commercial Applications covers Kinetico Water Softeners, Filters, Membrane Systems and Deionization Systems installed in any application other than a single family dwelling. Your system must be sold to you by an authorized Kinetico dealer and installed, operated and serviced in accordance with Kinetico's recommendations and any applicable codes in order to receive coverage under this Limited Warranty. The design of the overall treatment system and the performance of your system is related to the chemistry of the water being treated; therefore, this warranty is limited solely to the equipment manufactured and distributed by Kinetico, including replacement product and parts.

This Limited Warranty on the commercial reverse osmosis membrane **does not** include damage due to scaling, iron and bacterial fouling or freezing. Periodic replacement of filter cartridges and certain filter media (such as carbon, Birm**, calcite, Filter-Ag**, UltrAsorb™, Chloraban™, Sulfaban™ or SRS media) is part of the normal maintenance required by your system. These replacements and media loss due to natural attrition are not covered.

This limited warranty does not include damage to your system due to:

- Abuse, misuse or neglect
- Excessive pressure (as specified on product's data sheet)
- Excessive water temperature (as specified on product's data sheet)
- Freezing, alterations or misapplication
- A change in the influent water characteristics
- Power surges
- Influent water conditions outside product data sheet specifications

To place your system under this Limited Warranty, your authorized Kinetico dealer must register your equipment with Kinetico Incorporated within 30 days of the installation date. For service under this Limited Warranty, contact your authorized Kinetico dealer. Retain your receipt along with this Limited Warranty for reference if service is necessary.

No Other Warranties
